RING ENERGY, INC., a Nevada corporation having an address of 901 West Wall Street, Suite 300, Midland, Texas 79701 (the “Assignor”), for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby GRANT, BARGAIN, TRANSFER, CONVEY, SET OVER, ASSIGN and DELIVER effective as of 12:01 a.m. Central Standard Time, July 1, 2017 (the “Effective Time”) unto Calvin R. Hullum, Jr., having an address of P.O. Box 521008, Tulsa, Oklahoma 74152 (the “Assignee”), all of Assignor’s right, title and interest in and to the property described in the following subparagraphs (a), (b), (c), (d) and (e) (all of such rights, titles and interests in such property being hereinafter collectively referred to as the “Assets”), to-wit:

- (a) Leases, Lands and Wells. The (i) Oil and Gas Leases (the “Leases”), the Lands (the “Lands”) and the Wells (the “Wells”, together with the Leases and the Lands, the “Subject Properties”) described on Exhibit A; and (ii) the units, pooled acreage, spacing or proration units or other allocation of acreage applicable to the Subject Properties established by or in accordance with the applicable state, federal or local law;
- (b) Production. Hydrocarbons produced from or allocable to the Subject Properties for periods on or after the Effective Time and the proceeds therefrom;
- (c) Equipment. 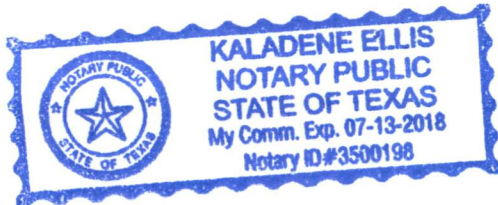
