**SALT WATER DISPOSAL LEASE, EASEMENT AND
RIGHT OF WAY**

THIS AGREEMENT made and entered into this 16th day of June, 2017, by and between **Marvin Leiker, 1678 230th Ave, Hays, Kansas**, herein called "**Lessor**," and **Kopfman, Inc., dba H & W Oil Company, Hays, Kansas** hereinafter called "**Lessee**."

NOW WHEREAS, Lessor is the owner of the following described real estate,
to-wit:

A portion of the Northwest Quarter (NW/4) of Section Four (4), Township Fifteen (15) South, Range Eighteen (18) West of the 6th P.M., Ellis County, Kansas;

AND WHEREAS, Lessee is the owner of and Lessee H & W Oil Company is the operator of a salt water disposal well situated in the Nourtheast Quarter of the Southeast Quarter of the Northwest Quarter (NE/4 SE/4 NW/4) of Section Four (4), Township Fifteen (15) South, Range 18 (18) West of the 6th P.M., Ellis County, Kansas;

AND WHEREAS, Lessor desires to grant to Lessee the right to maintain and operate a salt water disposal well which may be available for the disposal of slat water and other oilfield brines which may be produced from oil and gas leases in central Kansas and transported to said salt water disposal well by tank truck or other means.

NOW THEREFORE, for and in consideration of these premises, the parties agree as follows:

1. L e s s o r d o e s hereby let and lease unto Lessees the right and privilege to operate, maintain and repair upon the above described real estate a salt water disposal well for the purpose of disposing and injecting therein salt water and other oilfield brines which may be produced from wells situated in central Kansas, together with the right of ingress and

egress thereto at all times for the purpose of repairing and maintaining said disposal well and for the purpose of transporting salt water and other oilfield brines to the disposal well.

2. F o r the rights and privileges herein granted, Lessee shall pay to Lessor rental of Six Hundred Dollars (\$600) per Year in advance on the 1st day of each year, as long as well is TA'd. If well is completed, rent of Twelve Hundred Dollars (\$1200) per year will be immediately payable and due.


3. L e s s e e will manage and operate said salt water disposal well in a good and workmanlike manner and will at all times keep any salt water and other oilfield brines safely confined within the tanks and appurtenances to said well. Lessee will pay to Lessor their actual damages which may be sustained to said lands and/or any growing crops on said lands by reason of any construction, operation or maintenance of said salt water disposal well and the lines, connections and appurtenances thereto.

4. This Salt Water Disposal Lease, Easement and Right of Way shall continue in full force and effect so long as Lessee shall continue to operate and maintain said salt water disposal well and make payment of the rental. In the event Lessee fails to pay any rental payment due, this Salt Water Disposal Lease, Easement and Right of Way shall not be terminated unless Lessor has given Lessee a written notice of such failure to pay and Lessee shall still have failed to make payment of said rental within ten (10) days of the date of Lessee's receipt of said written notice.

5. L e s s e e shall have the right at any time to terminate Lessee's use and maintenance of said salt water disposal well, and upon such termination, shall have a reasonable time thereafter in which to remove from the premises all property which Lessee may have constructed and used in the operation and maintenance of said salt water disposal well. Upon termination, Lessee shall properly plug and abandon any salt water disposal well and restore the surface of said lands to its natural condition as nearly as may be practical.

6. The terms and provisions hereof shall constitute the entire agreement by and between these parties and shall not be and shall not be subject to alteration, change or modification except in writing signed by the parties hereto, and shall be and remain in full force and effect as between these parties, their heirs, personal representatives, successors and assigns.
