KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, LASSO HOLDING LLC, whose address is P.O. Box 465, 1125 South Main, Chase, Kansas 67524-0465. (hereinafter called "Assignor"), for and in consideration of the sum of One Hundred Dollars (\$100.00) and other good and valuable consideration, the receipt whereof is hereby acknowledged, does hereby sell, assign, transfer and set over unto KELSO OIL AND GAS INC, whose address is P.O. (hereinafter called "Assignee"), as of the Effective Time, thirty three and one third percent (33.333333333333%) gross working interest (1/3rd of 8/8ths) of Assignor's right, title and interest in and to the following (all of which are called the "Assets"):

1. The oil and gas leases specifically described in Exhibit "A" (collectively, the "Leases"), together with the rights incident thereto and the personal property thereon, appurtenant thereto, or used or obtained in connection therewith, including but not limited to the property, estates and rights described in paragraphs 2 through 4 below, and any and all right, title and interest in and to the oil, gas and all other hydrocarbons and other minerals, of whatever nature, in, on or under the lands covered by the Leases (the "Lands") and other hydrocarbons and products, whether liquid or gaseous, produced in association therewith ("Hydrocarbons") in, on or under the Leases and Lands and lands pooled or unitized therewith;

2. The oil and gas wells located on the Leases and Lands, or lands pooled or unitized therewith, including without limitation, the oil and gas wells specifically described in Exhibit "A", whether producing or non-producing and whether fully or properly described or not, (the "Wells"), all injection and disposal wells on the Leases or Lands, and all of the personal property, fixtures, improvements, permits, licenses, approvals, servitudes, rights-of-way and easements, surface leases and other surface rights (including, but not limited to, any wells, tanks, boilers, buildings, injection facilities, salt water disposal facilities, compression facilities, gathering systems, other appurtenances and facilities) located on or used in connection with or otherwise related to the exploration for or production, gathering, treatment, processing, storing, sale or disposal of Hydrocarbons or water produced from the Land and Leases.

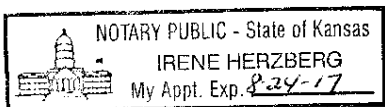
