C12: Kansas Oil, LLC, a Delaware Limited Liability Company (“Assignor”), for Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby GRANT, SELL, CONVEY, ASSIGN, and TRANSFER unto Fossil Creek Energy, LLC, a Colorado Limited Liability Company (“Assignee”) (Assignor and Assignee are sometimes referred to herein individually as “Party” and collectively as “Parties”), all of Assignor’s right, title and interest in and to the following assets, all located in the county and state named above, subject to the reservations set forth herein:

- a. The oil and gas leases as more particularly described on Exhibit A attached hereto and including all oil and gas leases owned by Assignor on lands in Russell County, Kansas whether accurately described on Exhibits A, A-1, and A-2 or not, but not including the “Excluded Assets” listed on Exhibit D attached hereto (collectively the “Leases”), including all rights and interests attributable or allocable to the Leases, including overriding royalty interests, by virtue of pooling, unitization, communitization, operating or similar agreements;
- b. All of Assignor’s interests in and to all the property and rights incident thereto, including but not limited to, all of Assignor’s interests and rights under any and all easements, surface agreements, salt water disposal agreements and rights-of-way, and under any and all contracts, agreements, leases, permits, licenses, farmouts, options, orders, and other arrangements of similar nature (including without limitation those contracts and agreements identified on Exhibit C attached hereto) to the extent any of the foregoing relates to the Leases and to the extent assignable or transferable, but not including the Excluded Assets (collectively the “Contracts”);
- c. The wells (including without limitation the wells identified on Exhibit B attached hereto), equipment, materials and other personal property, fixtures and improvements on the Leases as of the Effective Time, appurtenant thereto or used or obtained in connection with the Leases or with the production, treatment, sale or disposal of hydrocarbons or waste produced therefrom or attributable thereto, and all other appurtenances thereto belonging, but not including the Excluded Assets (including without limitation the Equipment and Personal Property listed on Exhibits B-1, B-2, B-3, B-4 attached hereto), (collectively the “Wells and Equipment”);
- d. To the extent assignable or transferable, all books, records, files, muniments of title, core analyses, reports and similar documents and materials, including without limitation lease records, well records, and division order records, well files, engineering and/or production files, title records (including abstracts of title, title opinions, and memoranda,

and title curative documents related to the Interests), and contracts, contract files and correspondence that relate to the foregoing in the possession of and maintained by Assignor, but not including the Excluded Assets, PROVIDED HOWEVER, that the cost for delivery of items under this paragraph shall be at Assignee's sole expense; and

- e. All of Assignor's rights as to revenues or volumes resulting from settlement of any imbalance created by underproduction attributable to Assignor's interest in the Leases before the Effective Time.

To the extent assignable or transferable, this Assignment and Bill of Sale ("Assignment") includes, and it is the intention of the Parties to include, all of Assignor's right, title and interest in Assignor's oil and gas interests located in Russell County, Kansas, except for the Excluded Assets, regardless of whether such interests are identified herein or in the exhibits attached hereto, PROVIDED, HOWEVER, that Assignor hereby reserves unto itself a 1.5% overriding royalty interest in and to each of the operated oil and gas leases assigned by this Assignment and all extensions and renewals thereof. Said Overriding Royalty shall be free and clear of all development, production, marketing and operating expenses.

This Assignment is expressly made subject to the terms of the Purchase, Sale, and Option Agreement entered into effective November 1, 2017 by and between Assignor and Assignee (the "Purchase Agreement"). The Purchase Agreement provides Assignor with a buyback option to repurchase up to a 30% working interest in the leases assigned by the Assignment and in any additional leases acquired by the Assignee, on the terms and conditions set forth in the Purchase Agreement.

All of Assignor's interest in the assets described in paragraphs a, b, c, d and e above are collectively referred to herein as the "Interests."

To have and to hold the Interests unto Assignee, its successors and assigns, forever, subject to the following terms and conditions:

1. This Assignment is accepted by Assignee subject to, and Assignee agrees to assume and perform, all liabilities and obligations, or alleged or threatened liabilities and obligations, of Assignor under or otherwise associated with the Interests, Contracts, assignments, operating agreements, product purchase and sale contracts, leases, permits, rights-of-way, licenses, easements, options, orders, and any other agreements or contracts attributable to and affecting the Interests, including but not limited to, any and all obligations, regardless of whether such liabilities and obligations, or alleged threatened liabilities and obligations, are caused solely or in part by the gross, active, passive, or concurrent negligence, strict liability or other fault of Assignor and regardless of whether such matters arose before, on or after the Effective Time, including without limitation all liabilities and obligations, or alleged or threatened liabilities and obligations (i) to pay and deliver royalties, overriding royalties, non-participating royalties, and other burdens on production (including funds held in suspense by Assignor with respect to periods before the Effective Time, which shall have been assigned or otherwise credited to Assignee); (ii) in connection with or arising out of balancing of overproduction or underproduction from the Interests; (iii) to comply with all applicable laws and governmental regulations with respect to the Interests, including but not limited to the lawful plugging and abandonment of oil and gas wells and the restoration of the surface of the land as nearly as possible to its pre-lease condition; (iv) to pay all costs and expenses relating to the Interests which accrue after the Effective Time; and (v) to file with all applicable governmental authorities the necessary forms to transfer ownership and operatorship of any wells conveyed by this Assignment from Assignor to Assignee. Without limitation of the foregoing, Assignee agrees to assume and perform all liabilities and obligations, or alleged or threatened liabilities and

obligations, of Assignor for claims, losses, damages, costs, expenses, diminutions in value, suits, and causes of action of any kind or character, with respect to the ownership and operation of the Interests, including without limitation the environmental condition of the Interests, regardless of whether the events giving rise to such claims occurred before, on, or after the Effective Time and whether or not caused by or attributable to, in whole or in part, gross, active, passive or concurrent negligence, strict liability or other fault of Assignor.

2. ASSIGNEE SHALL, TO THE FULLEST EXTENT PERMITTED BY LAW, PROTECT, DEFEND, INDEMNIFY AND HOLD HARMLESS ASSIGNOR AND ASSIGNOR'S DIRECTORS, OFFICERS, EMPLOYEES, AGENTS, AND MEMBERS, AND REPRESENTATIVES OF EACH OF THEM, FROM AND AGAINST ANY AND ALL CLAIMS, LOSSES, DAMAGES, COSTS, EXPENSES, DIMINUTIONS IN VALUE, SUITS, CAUSES OF ACTION OR JUDGMENTS OF ANY KIND OR CHARACTER WITH RESPECT TO ANY AND ALL LIABILITIES AND OBLIGATIONS OR ALLEGED OR THREATENED LIABILITIES AND OBLIGATIONS, INCLUDING BUT NOT LIMITED TO ANY INTEREST, PENALTY AND ATTORNEYS' FEES AND OTHER COSTS AND EXPENSES INCURRED IN CONNECTION WITH INVESTIGATING OR DEFENDING ANY CLAIMS OR ACTIONS, WHETHER OR NOT RESULTING IN ANY LIABILITY, ATTRIBUTABLE TO OR ARISING OUT OF THE OWNERSHIP OR OPERATION OF THE INTERESTS BEFORE, ON AND AFTER THE EFFECTIVE TIME, INCLUDING WITHOUT LIMITATION ANY OF THE FOLLOWING: (i) ALL RISKS, OBLIGATIONS, RESPONSIBILITIES, OR LIABILITIES ASSUMED BY ASSIGNEE UNDER THIS ASSIGNMENT, (ii) ALL CONTRACTS RELATING TO THE INTERESTS AND THE PLUGGING, ABANDONMENT, AND DECOMMISSIONING OBLIGATIONS (INCLUDING ASSIGNEE'S FAILURE TO TIMELY AND FULLY SATISFY SUCH OBLIGATIONS); (iii) CLAIMS FOR TAXES WHICH ARE THE OBLIGATION OF ASSIGNEE, INCLUDING ANY COURT COSTS AND ATTORNEYS', EXPERT WITNESS' AND OTHER ADVISOR'S FEES; AND (iv) ALL ENVIRONMENTAL OBLIGATIONS OF ASSIGNOR WITH RESPECT TO THE INTERESTS, INCLUDING WITHOUT LIMITATION THE PRESENCE OF NATURALLY OCCURRING RADIOACTIVE MATERIAL (NORM), ASBESTOS, OR OTHER HAZARDOUS SUBSTANCES.

THE INDEMNIFICATION, RELEASE, HOLD HARMLESS, AND ASSUMPTION PROVISIONS IN THIS ASSIGNMENT SHALL APPLY REGARDLESS OF WHETHER THE LOSSES, COSTS, EXPENSES AND DAMAGES IN QUESTION AROSE SOLELY OR IN PART FROM THE GROSS, ACTIVE, PASSIVE, OR CONCURRENT NEGLIGENCE OR OTHER FAULT OF ASSIGNOR AND REGARDLESS WHETHER LOSSES, COSTS, EXPENSES AND DAMAGES IN QUESTION AROSE OR OCCURRED BEFORE, ON OR AFTER THE EFFECTIVE TIME.

3. THIS ASSIGNMENT IS EXECUTED, DELIVERED, AND ACCEPTED WITHOUT ANY REPRESENTATION, WARRANTY OR COVENANT OF TITLE OF ANY KIND OR NATURE, EITHER EXPRESS, IMPLIED OR STATUTORY. THE INTERESTS ARE BEING CONVEYED AND ASSIGNED TO AND ACCEPTED BY THE ASSIGNEE IN THEIR "AS IS, WHERE IS" CONDITION AND STATE OF REPAIR, AND WITH ALL FAULTS AND DEFECTS, WITHOUT ANY REPRESENTATION, WARRANTY OR COVENANT OF ANY KIND OR NATURE, EXPRESS, IMPLIED, OR STATUTORY, INCLUDING BUT NOT LIMITED TO COMPLIANCE WITH APPLICABLE LAWS AND REGULATIONS, WARRANTIES OF MARKETABILITY, QUALITY, CONDITION, MERCHANTABILITY, AND/OR FITNESS FOR PARTICULAR PURPOSE, ALL OF WHICH ARE EXPRESSLY DISCLAIMED. IT IS UNDERSTOOD AND AGREED THAT ASSIGNEE SHALL ACCEPT ALL OF THE INTERESTS IN THEIR "AS IS, WHERE IS" CONDITION AND STATE OF REPAIR AND WITH ALL FAULTS AND DEFECTS, INCLUDING WITHOUT

LIMITATION THE ENVIRONMENTAL CONDITION OF THE INTERESTS, INCLUDING WITHOUT LIMITATION THE PRESENCE OF NORM, ASBESTOS, OR OTHER HAZARDOUS SUBSTANCES. IN ADDITION, ASSIGNOR MAKES NO REPRESENTATION, COVENANT OR WARRANTY, EXPRESS, IMPLIED OR STATUTORY, AS TO THE ACCURACY OR COMPLETENESS OF ANY DATA DELIVERED TO ASSIGNEE WITH RESPECT TO THE INTERESTS, CONCERNING THE QUALITY OR QUANTITY OF HYDROCARBON RESERVES, IF ANY, ATTRIBUTABLE TO THE INTERESTS, THE ABILITY OF THE INTERESTS TO PRODUCE HYDROCARBONS, THE PRICES WHICH ASSIGNEE IS OR WILL BE ENTITLED TO RECEIVE FOR ANY SUCH HYDROCARBONS, OR THE CONTENT, CHARACTER, OR NATURE OF GEOLOGICAL, GEOPHYSICAL, TECHNICAL, ENGINEERING (INCLUDING PETROLEUM ENGINEERING), ECONOMIC, OR OTHER INTERPRETATIONS, FORECASTS, EVALUATIONS, OR COST ESTIMATES CONCERNING THE INTERESTS.

4. ASSIGNEE FURTHER ACKNOWLEDGES, AGREES TO, AND ASSUMES THE RISK OF, THE FOLLOWING:

- a. That the Interests have been used for oil and gas exploration, drilling, and producing operations, pipeline, transportation, or gathering operations, and other related oilfield or processing operations, including, possibly the injection, storage, or disposal of produced water or hazardous or waste materials incidental to or occurring in connection with such operations.
- b. That physical changes in the land, groundwater or subsurface may have occurred as a result of any such uses and that Assignee has entered into this Assignment on the basis of Assignee's own investigation of, or right to investigate, the physical condition of the Interests, including the Wells and Equipment and the surface and subsurface conditions.
- c. Assignee assumes the risk that adverse physical conditions, including the presence of unknown, abandoned, or unproductive oil wells, gas wells, equipment, pits, landfills, flowlines, pipelines, water wells, injection wells, and sumps, which may or may not have been revealed by Assignee's investigation, are located thereon or therein, and whether discovered, discoverable, hidden, known, or unknown to Assignee as of the Effective Time.
- d. That none of the bonds posted by Assignor with any governmental authority having jurisdiction over the Interests are being transferred to Assignee.
- e. Assignee has had a reasonable opportunity to examine title and other agreements affecting or relating to the Interests, and that Assignor makes no representations or warranties regarding the information in any of their lease and well files as to accuracy, completeness, or usefulness for title examination, for evaluation of the worth or condition of the Interests, or for any other purpose. Assignee hereby waives for all purposes all objections, defects, and claims (whether known or unknown) associated with title to or the environmental condition of the Interests.
- f. From and after the date hereof, Assignee covenants and agrees to assume full responsibility for compliance with all obligations, including environmental obligations, attributable in any way to the Interests and all laws, orders, rules, and regulations concerning all of such conditions, discovered, discoverable, hidden, known, or unknown.

- g. Assignee has made, or arranged for others to make, or has been afforded the opportunity to make, an inspection and inventory of the Interests and, if not performed, waives such right.
- h. Assignee affirms that it is relying only on its own independent investigation, analysis, and evaluation of the geological, geological engineering, economic or other interpretations, and the costs of and prospects for further development in relation to the Interests, including any future and current taxes in relation to the Interests, and the advice of its counsel or other advisors.
- i. That Assignor cannot and does not covenant, warrant, or guarantee that Assignee will become successor operator of the Interests or portions of the Interests which Assignor may presently operate, should any be subject to unit, pooling, communitization, or operating agreements or other agreements that control the appointment of a successor operator. Assignee agrees that it will, to the extent permitted by applicable agreements and laws, undertake to obtain unconditional approval from all regulatory agencies, non-operators, and lessors, if necessary, to succeed Assignor as operator of the Interests (or any portion thereof) and to assume full responsibility therefor, and Assignee will file all bonds, permits, requests, letters of credit, and forms necessary or helpful for the designation of Assignee as operator of the Interests.
- j. Assignee acknowledges each of the disclaimers set forth in this Assignment and acknowledges and affirms that it has not relied upon any representation, warranty, collateral contract, statement, assurance, opinion, or information from Assignor or its agents in entering into or carrying out the transactions contemplated by this Assignment and Assignee waives all rights and remedies which but for this Section 4 would or might have been available to it in respect of such representation, warranty, collateral contract, statement, assurance, opinion, or information. Assignee assumes all risk and liability incident to the condition and use of the Interests and Assignor has no further liability or obligation with respect to the Interests.

5. This Assignment shall inure to the benefit of and be binding upon the Parties and their heirs, successors and assigns.

6. All ad valorem taxes, real property and similar obligations for the current tax year shall be prorated as of the Effective Time based upon the current year tax rate and evaluation, and settlement shall be made as soon as possible after the date of this Assignment.

7. All proceeds (including proceeds held in suspense or escrow) from the sale of production actually sold and delivered by Assignor before the Effective Time and attributable to the Interests shall belong to Assignor and all proceeds from the sale of production actually sold and delivered after the Effective Time attributable to the Interests shall belong to Assignee. In addition, all oil, condensate or liquid hydrocarbons (hereinafter in this paragraph called "oil") in storage above the pipeline connection shall be sold down to the sales valve on the day before the Effective Time. Assignee agrees to coordinate with oil haulers to work on schedule to ensure the oil is sold on October 30, 2017 and October 31, 2017, with a reasonable effort to haul smaller leases on October 30, 2017 and to haul the bigger leases on October 31, 2017. To the extent either Party receives a revenue, benefit or other income that the other Party is entitled to receive, the receiving Party will account to the other Party within ten (10) business days. To the extent a Party pays a cost or expense for which the other Party is responsible to pay, upon

receiving written notice from the paying Party and evidence of the cost or expense and the actual payment thereof, the non-paying Party will reimburse the paying Party within ten (10) business days. 

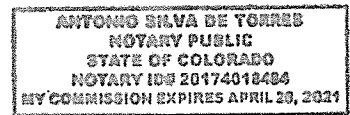
