
together with the rights incident thereto along with all equipment, well bores, pipe and other personal property thereon, appurtenant thereto, or used or obtained in connection therewith.


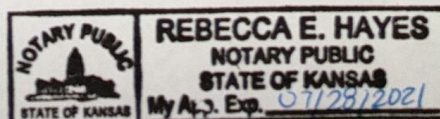
