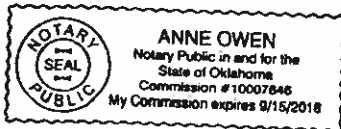

NE/4 of Section 18, Township 34 South, Range 12 East, of the 6<sup>th</sup> P.M. EXCEPT:

(Tract #1 Exception): A tract commencing at the NW corner of the Northeast Quarter (NE/4) running thence South on the half section line to the center of the Channel of the Middle Caney River, thence following down the Channel of said river in an easterly direction as it runs through said quarter section a sufficient distance to include 60 acres within the lines of the tract herein described, thence North to the North line of said quarter section, thence West on the North line of said quarter section to place of beginning;

(Tract #2 Exception): ALSO FURTHER EXCEPTING a tract described as follows: Beginning at a point in the middle of the Middle Caney River on the West line of the Northeast Quarter (NE/4) of Section 18, thence down said stream in the middle of the channel, 60 rods to a point opposite a rock nearly cubic in shape and 14 feet high on the South bank of said stream, thence South about 5 rods to the top of the bluff, thence West by Southwest along the top edge of said bluff to the West line of said quarter section, thence North on the West line to place of beginning, Section 18, Township 34 South, Range 12 East, of the 6<sup>th</sup> P.M., containing 243 acres, more or less.
