Hill Lease:

An oil and gas lease from Dusty L. and Joni R. Booth, husband and wife, as lessors to Daystar Petroleum, Inc. as lessee, dated July 1, 2011, and recorded in Book 51 Page 265 in the office of the Register of Deeds of Greenwood County, Kansas, covering the following described real estate to-wit: The South Half of the Southeast Quarter (S $\frac{1}{2}$ SE $\frac{1}{4}$) of Section Thirty-four (34), Township Twenty-four (24) South, Range Nine (9) East of the Sixth Principal Meridian of Greenwood County, Kansas


