
Owner Operator Agreement

North American Drilling & Exp Inc, hereafter referred to as owner operator, agrees to transfer all ownership and operations to Mike Kelso Inc, hereafter referred to as new owner operator, all ownership to the Ward #1 well located in Stafford Co. Kansas in Section 2 Township 24s Range 15w covering 160 acres.

New owner operator agrees to work over and produce the Ward well to the best of his ability and also agrees to attempt to produce oil and gas from any promising formation before abandonment. New owner operator further agrees to dispense the pro rata share of income from Ward well to existing working interest owners after operating expenses have been removed.

Owner operator agrees to furnish new owner operator with names and addresses of each working interest owner. New owner operator also agrees to mail landowner standard 1/8 share to name and address provide. New owner operator further agrees to send over-riding royalty amounts shown in assignment of oil and gas lease to names and addresses provided.

New owner operator agrees to put the Ward #1 well back into production in a timely manner to the best of his ability.
