## CONTRACT AND AGREEMENT FOR BILL OF SALE

This contract and Agreement made and entered into effective the 14<sup>th</sup> day of March, 2018, by and between Mack Energy Co., whose mailing address is P.O. Box 400, Duncan, Oklahoma 73534, hereinafter referred to as "Mack" and Castle Resources, Inc, whose mailing address is PO Box 583, Russell, Kansas 67665, hereinafter referred to as "Castle".

WITNESSETH:

WHEREAS, Mack desires to sell all working interests and associated leasehold thereto associated with the Lula and Horchem leases, more specifically defined as being located in W/2 of Section 31-17S-23W and NW/4 of Section 2-17S-24W, Ness County, KS; and

WHEREAS, Castle desires to acquire Mack's working interests, and associated leasehold;

NOW THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth the parties hereto agree as follows:

### AGREEMENT

1. On or before March 14, 2018, Castle will submit \$25,000 to Mack;
2. On or before March 14, 2018, Mack will transfer Operations to Castle.
3. Castle will receive all income from these properties and be responsible for all expenses after 11:59pm, Wednesday, March, 14, 2018.
