Witnesseth that for good and valuation in consideration, the receipt of which is hereby acknowledged, the Assignor herein does assign to the Assignee as of the effective date of **March 1<sup>st</sup>, 2018** (the "Effective Date"):

1. All of Assignor's Right, Title and Interest amounting to (100%) of their working interest as it pertains to the wells listed on **Exhibit A**, together with the leases and equipment pertaining to same, described on Exhibit A attached hereto (the "Wells");
2. All rights of way and easements situated upon or used or held with the exploration, development, operation or maintenance of the Wells and leases;
3. All equipment used or useful in the production of the Wells and situate on said premises, including but not limited to, all pumpjacks, tanks, separators, meters, pipelines and other equipment;
4. All contracts and agreements relating to the ownership and operating of the Wells; and
5. All records and files in Assignor's possession relating to the assets transferred herein.

Assignor represents that, to the best of Assignor's knowledge the following does and will exist as of the Effective Date:
