ASSIGNMENT OF OIL AND GAS LEASE

And hereinafter referred to as the **SUBJECT PROPERTY**.

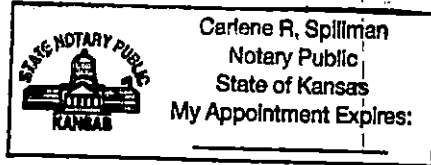
