ASSIGNMENT OF OIL AND GAS LEASE AND BILL OF SALE

NOW, THEREFORE, for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, “ASSIGNOR” does hereby sell, assign, grant, transfer and set over unto **American Oil, LLC**, 1023 Reservation Road, Hays, KS 67601, hereinafter called “ASSIGNEE”, its heirs and assigns, all of its right, title and working interest (excluding any royalty interest or overriding royalty interest), in and to the above described Oil and Gas Lease together with all equipment located thereon and or appurtenant to, or used or obtained in connection therewith.

“ASSIGNOR” also grants, sells, conveys and transfers unto “ASSIGNEE” all of “ASSIGNOR’S” right, title and interest in and to all easements, right of ways, salt water disposal agreements and any other agreement used or in any way pertaining to the oil and gas leasehold estates transferred herein.

This Assignment of Oil and Gas Lease and Bill of Sale is executed without any warranty of title, either express or implied, without any express or implied warranty or representation as to the merchantability of any of the wells and appurtenances or its fitness for any purpose. It is understood and agreed that “ASSIGNEE” has inspected or had sufficient opportunity to inspect the assigned interests and is satisfied as to its physical and environmental condition, both surface and subsurface, and that “ASSIGNEE” accepts all of the same in “AS IS”, “WHERE IS” condition. In addition, “ASSIGNOR” makes no warranty or representation, express or implied, as to the accuracy or completeness of any data, information or materials heretofore or hereafter furnished “ASSIGNEE” in connection with the interests, or as to the quality or quantity of hydrocarbon reserves (if any) attributable to the interests or the ability of the interests to produce hydrocarbons, any and all such data, information and other materials furnished by “ASSIGNOR” is provided to “ASSIGNEE” as a convenience and any reliance on or use of the same shall be at “ASSIGNEE’S” sole risk. Notwithstanding the foregoing, Assignor warrants and defends that said interest is free and clear of all liens, mortgages, production payments, or encumbrances of any kind.
