

**AGREEMENT OF THE BENEFICIARIES AS TO OIL AND GAS  
INTERESTS HELD BY THE DONALD E. BRICKLEY AND  
JEAN B. BRICKLEY REVOCABLE TRUST, DATED JUNE 8, 2007**

THIS AGREEMENT is entered into as of the date of full-execution of this Agreement

BETWEEN:

**JOHN A. BRICKLEY**, son of Donald E. and Jean B. Brickley, the Settlers of the Donald E. Brickley and Jean B. Brickley Revocable Trust, dated June 8, 2007 ("the Trust"), a Trustee and Beneficiary ("Trustee" and "Beneficiary");

**JAN L. THOMPSON**, daughter of Donald E. and Jean B. Brickley, the Settlers of the Trust, and beneficiary of the Trust ("Beneficiary");

**KAY L. TAYLOR**, daughter of Donald E. and Jean B. Brickley, the Settlers of the Trust, and beneficiary of the Trust ("Beneficiary");

**MEGAN CROSLEY**, daughter of Gay A. Crosley, the daughter of Donald E. and Jean B. Brickley, the Settlers of the Trust, and beneficiary of the Trust ("Beneficiary");

**ALISHA CROSLEY**, daughter of Gay A. Crosley, the daughter of Donald E. and Jean B. Brickley, the Settlers of the Trust, and beneficiary of the Trust ("Beneficiary");

**JADON CROSLEY**, son of Gay A. Crosley, the daughter of Donald E. and Jean B. Brickley, the Settlers of the Trust, and beneficiary of the Trust ("Beneficiary"); and

**STEVE CROSLEY**, widower of Gay A. Crosley, the daughter of Donald E. and Jean B. Brickley, the Settlers of the Trust, and legal guardian of Jadon Crosley.

RECITALS:

A. The Trustee currently serves as Trustee of the Trust, pursuant to Article 3.1 of the Trust.

B. The Trustee and Beneficiaries are the holders of all the Trust assets and currently the sole beneficiaries of the Trust and have agreed to distribute any and all oil and gas interests held by the Trust, rather than to be distributed at a later time to the Brickley Mineral Trust, as provided for in Article 2.2(D), as agreed upon below.

NOW THEREFORE, in consideration of the premises and the respective rights and obligations set out herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto do hereby covenant and agree as follows:

**ARTICLE 1  
INTERPRETATION**

**1.1 Oil & Gas Interests**

"Oil and Gas interests" means all of the oil and gas interests of the Trust of every kind and nature whatsoever, including, but not limited to, royalty, overriding royalty, leasehold interests, interests in wells, and mineral interest.

**1.2 Time of Essence**

Time shall be of the essence of this Agreement.

**1.3 Applicable Law**

This Agreement shall be governed by and construed in accordance with the laws of the State of Kansas.

**1.4 Successors and Assigns**

This Agreement shall inure to the benefit of and shall be binding on and enforceable by the parties and, where the context so permits, their respective successors and permitted assigns.

**1.5 Severability**

If any provision of this Agreement is determined by a court of competent jurisdiction to be invalid, illegal or unenforceable in any respect, such determination shall not impair or affect the validity, legality or enforceability of the remaining provisions hereof, and each provision is hereby declared to be separate, severable and distinct.

**ARTICLE 2  
OIL AND GAS INTERESTS**

**2.1 Distribution of the Oil and Gas Interests of the Trust**

The Trustee and Beneficiaries hereby agree that, after fully understanding and contemplating the effect of this Agreement, the Trustee on behalf of the Trust shall distribute and assign the oil and gas interests held by the Trust. The Trustee and Beneficiaries agree that by the execution of this Agreement, all parties are in agreement with the distribution of the oil and gas interests held by the Trust, and therefore foregoing later distribution of the oil and gas interests to a yet to be created Brickley Mineral Trust.

The Trustee and Beneficiaries agree that the distribution/assignment shall be as follows:

**A. Craylor, LLC Assignment**

- a. For the benefit of Kay L. Taylor, Megan Crosley, Alisha Crosley and Jadon Crosley
- b. Leases operated by Taylor Oil Co.
- c. Leases: Loomis A, Loomis B, Parry, Claassen, Brewer and Chinn

**B. John A. Brickley Assignment**

- a. For the benefit of John A. Brickley and Jan L. Thompson
- b. Leases operated by Brickley Enterprises, LLC
- c. Leases: Cabeen, Seglem, Blakeman (North & South), Brissey, Harmon and Houston



## **2.2 Indemnification/Hold Harmless**

The Trustee and Beneficiaries agree to hold each other harmless and indemnify the other for any and all claims that may arise as a result of the assignment/distribution made in accordance with this Agreement. This Hold Harmless and Indemnification clause is made between the parties only in contemplation of any potential claims made that the oil and gas interests in the Trust should have been distributed to not yet formed Brickley Mineral Trust, rather than distributed and assigned as provided for in Section 2.1 of this Agreement.

## **ARTICLE 3 MISCELLANEOUS**

### **3.1 Care of Donald E. and Jean B. Brickley**

The Trustee and Beneficiaries agree that Craylor, LLC and John A. Brickley shall each pay \$3,500 per month (total of \$7,000) out of the revenues resulting from the assignments/distributions contemplated under Article 2.1, to Donald E. and Jean B. Brickley for their health, care, and maintenance ("care payments") until the survivor of Donald E. and Jean B. Brickley shall pass. The care payments shall be sent to PO Box 107, El Dorado, KS 67042. The Trustee and Beneficiaries agree that the health, care and maintenance needs of Donald E. and Jean B. Brickley shall be fully met until the survivor of Donald E. and Jean B. Brickley shall pass.

### **3.2 Further Assurances**

Each party hereby covenants and agrees that it will, from time to time and at all times hereafter, at the request of the Trustee, execute and deliver such further assurances, assignments, notices, releases, deeds, instruments and other documents and do all such further acts as may be reasonably required to fully perform, give effect to and carry out the provisions hereof.

### **3.3 Counterparts**

This Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

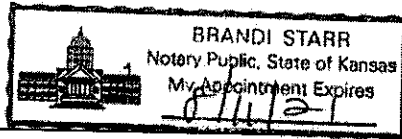

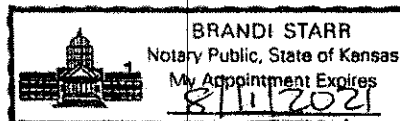

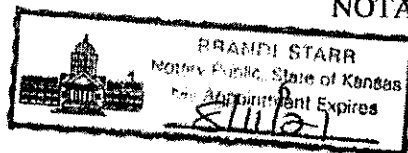
