

To Whom It May Concern:

This T-1 is a unique situation that requires additional explanation beyond what is available on the actual T-1 form. Hopefully this letter will provide the necessary additional information needed to process this transfer.

Thomas Enterprises Inc. of Kansas owns the real property that was encumbered by the Robert Kramer oil and gas lease (making them the Lessor). Due to some complications with operating the lease, KRED and Thomas Enterprises came to an agreement whereby KRED (and the other working interest owners) would simply release the oil and gas lease (and all equipment, wells, fixtures, etc.) back to the Lessor, Thomas Enterprises. Therefore, Thomas Enterprises is now the legal owner of the wells and equipment associated with the now defunct Robert Kramer lease. See the attached recorded Release.

Thomas Enterprises is not a licensed operator, but Joel Thomas is the President of both Thomas Enterprises and ST Petroleum, Inc. I have spoken with Joel, and he intends to have ST Petroleum take a new lease out on the property from Thomas Enterprises and continue operation of the wells under the new oil and gas lease between his two companies.

Therefore, both KRED and Thomas Enterprises would like the wells transferred to ST Petroleum, so that KRED can have the wells they no longer own removed from their inventory and ST Petroleum can get to work on the lease.
