#### CHANGE OF OPERATOR AGREEMENT

#### CASH CITY PROSPECT

This Change of Operator Agreement ("Agreement") is made effective 12:01 am September 1, 2018 (the "Effective Date"), by and among MIDCO Exploration, Inc., a Illinois corporation whose address is P.O. Box 1278, Westmont, IL 60559 ("MIDCO"), and Younger Energy Company, a Kansas corporation whose address is 9415 E. Harry Street, Suite 403, Building 400, Wichita, KS 67207-5083 ("Younger"). MIDCO and Younger are sometimes referred to herein individually as a "party" and collectively as the "parties."

WHEREAS, MIDCO is transferring operations of certain Leases, Wells and Units to Younger as of the Effective Date. MIDCO and Younger each intending to be legally bound, agree as follows:

#### **CHANGE OF OPERATOR**

- 1.1 <u>Change of Operator.</u> MIDCO is the current operator of the Leases, Wells and Units identified below, transfers all rights to operate such Leases, Wells and Units to Younger, an operator duly qualified and approved to operate oil and gas well in the state of Kansas.
