

The interest hereby assigned is subject to its proportionate part of a total overriding royalty of 1/16 of 7/8 of all oil, gas and casing head gas produced saved and marketed from the herein described land. Said overriding royalty to be free and clear of any cost and expense of development and operation therefrom, excepting transportation costs and taxes applicable to said interest and the production therefrom.

And for the same consideration the Assignor covenants with the Assignees, it or his heirs, successors or assigns: That the Assignor is the lawful owner of and has good title to the interest above assigned in and to said lease, estate, rights and property, free and clear from all liens, encumbrances or adverse claims; That said lease is a valid and subsisting lease on the land above described, and all rentals and royalties due there under have been paid and all conditions necessary to keep the same in full force have been duly performed, and that Assignor will warrant and forever defend the same against all persons whomsoever, lawfully claim or to claim the same


