The Southwest Quarter (SW/4 of Section 11, Township 24 South, Range 18 East, Allen County, Kansas, containing 160 acres, more or less


together with the rights incident thereto and the personal property thereon, appurtenant thereto, or use, or obtained in connection therewith ("Lease").


