KNOW ALL MEN BY THESE PRESENTS, that for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned, SHORELINE RESOURCES, LLC (hereinafter "Assignor") does, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, sell, assign, transfer, and convey unto the following named Assignees, in the undivided percentages set forth opposite their names:

of all right, title and interest in and to the following (all of which are herein called the "Subject Properties"):

- a. The oil and gas lease and other leasehold interest described in Exhibit A (the "Leases"), all right, title and interest in and to the oil, gas and all other hydrocarbons, whether liquid or gaseous (the "Hydrocarbons"), in, on or under or that may be produced from the lands covered by the Lease (the "Lands") on and after the Effective Time and all other minerals of whatever nature in, on or under the Lease and Lands.
- b. The oil and gas wells located on the Lease and Lands, or lands pooled or unitized therewith (the "Wells"), all injection and disposal wells on the Lease or Lands, and all personal property and equipment associated with the Wells as of the Effective Date.
- c. The rights, to the extent applicable and transferable, in and to all existing and effective unitization, pooling and communitization agreements, declarations and orders, to the extent that they relate to or affect any of the Lease and/or Wells or the post-Effective Date production of Hydrocarbons from the Lease and Lands.

This Assignment and Bill of Sale is executed on the date indicated above, to be EFFECTIVE as of 12:01 a.m. local time on September 1, 2018.


