TDI Oil Operations, LLC, hereinafter called Assignor (whether one or more), for and in consideration of One Dollar (\$1.00), the receipt whereof is hereby acknowledged, does hereby sell, assign, transfer and set over unto Production Drilling Inc. (hereinafter called Assignee), all its interest, subject to the overriding royalty reservations hereinafter set out, in and to an Oil and Gas lease dated February 19, 2007, from Steven R. Baumrucker and Nancy E. Baumrucker, Lessor, to Tom Denning, d.b.a. T.D.I. Oil Operations, Lessee, recorded in Book 665, Page 290, insofar as said lease covers the following described land in Ellis County, State of Kansas:

The North Half of the Northeast Quarter (N/2 NE/4)


