FOR VALUABLE CONSIDERATION, the receipt and sufficiency of which is hereby acknowledged, **THE TREES OIL COMPANY**, a Kansas corporation, as Assignor, hereby sells, assigns, and transfers to **EDISON OPERATING COMPANY, LLC**, a Kansas limited liability company, as Assignee, all of its right, title, and interest in and to the Oil and Gas Leases and wells in described on Exhibit "A" (including any ratifications and amendments thereto) attached hereto and made a part hereof; and

HASKELL COUNTY, KANSAS

TOGETHER with all equipment and rights incident thereto or used or obtained in connection with the development and operation thereof and the personal property and fixtures thereon, appurtenant thereto, including but not limited to, working interest, reversionary interest, operations, associated leasehold rights, wells, equipment, pumping units, tanks, buildings, machinery, supplies, materials, compressors, compressor agreements, flow lines, gathering lines, rights-of-ways, easements, surface leases used in connection with oil and gas operations, attributable unit acreage, and salt water disposal wells and disposal systems, and other equipment located on and used in connection with the development, operation or maintenance of the oil and gas leases above described. All property herein conveyed is done so in an "as is, where is" condition.
