**Agreement to Sell and Purchase.** Subject to the terms and provisions of this Purchase and Sale Agreement the Sellers agree to sell and assign and Buyer agrees to purchase all of Seller's rights, titles, and working interest in and to certain oil and gas lease in Pawnee County, Kansas, or any extensions or renewals thereof, together with like interests in the rights incident thereto and all producing wells, service wells and related facilities, including all casing, pipe, tanks, equipment, materials and other personal property therein, thereon, appurtenant thereto or used or obtained in connection therewith, together with all oil, gas and other hydrocarbons produced from the lease described below.

It is understood that the assignment is intended to assign and will assign, transfer and set over unto Assignee all of its right, title and interest of Assignor in and to the subject property, together with a like interest of Assignor in and to all oil wells, gas wells, saltwater disposal wells, injection wells, tanks, pipeline, flow lines, water lines, power lines, telephone lines, roads, building, pumping units, casing, tubing and rods, and all other personal property, fixtures, and machinery in, on, or under such lands and used in connection with the development and operation of such lease, together with a fractional interest of Assignor in and to all permits, licenses, franchises, servitudes, easements and rights of way of every kind relating to such property which are useful or appropriate in exploring for, developing, operating, treating, storing or transporting oil, gas and other minerals on and from such lease, and a like interest of the Assignor in and to all operating agreements, gas sales agreements, or other contracts or agreements of every kind affecting such lease.

The subject property is being sold "AS IS WHERE IS", and Assignee herein agrees to assume responsibility for and agrees to plug and abandon the wells located on the subject property and to restore the surface of the subject property in accordance with applicable governmental rules, regulations, laws and orders and as may be required under any lease, contract or other agreement affecting subject property. In the event Assignee fails to do the foregoing, Assignor shall not be held liable for said responsibilities and/or obligations.

Oil remaining in the tanks shall belong to the Assignee and all oil and gas produced after the effective date hereof shall belong to the Assignee.

As of the effective date, Assignee shall be liable for all ad valorem taxes thereafter.

This sell shall be effective as of January 1, 2019 at 7:00 A.M.

Upon execution of assignments by all Sellers and upon receipt of well records, Buyer shall pay Seller an amount equal to [REDACTED] made payable to Rains & Williamson Oil Co., Inc. as operator and distributed proportionately to all working interest owners assigning their interest.
