

## SALT WATER DISPOSAL AGREEMENT

THIS AGREEMENT made and entered into this 11th day of October, 1995, by and between the WILLA HAIR LIVING TRUST, as Lessor, and RAINS & WILLIAMSON OIL CO., INC., of Wichita, Kansas, as Lessee,

WITNESSETH, THAT:

WHEREAS, Lessor, is the owner of the following described land located in Ness County, Kansas, covering:

The Southwes! Quarter (SW/4) of Section 6, Township 16 South, Range 21 West, and containing 160 acres, more or less

and,

WHEREAS, there is now located on a portion of said land a certain well located in the Center of the Northwest Quarter of the Southeast Quarter of the Southwest Quarter (C NW SE SW) of Section 6, Township 16 South, Range 21 West, Ness County, Kansas, known as the Ryan #2 well, which Lessee is using as a water input or disposal well for the disposal of salt water produced from wells in the vicinity, currently being disposed from.
