

Any claim against Assignor for breach of the special warranty of title herein shall be filed with the court on or before December 31, 2019 or such claim shall be deemed waived. All

2. MERGER OF OVERRIDING ROYALTY. The interest assigned herein consists partly of overriding royalty interest and partly of working interest.
