KNOW ALL MEN BY THESE PRESENTS:

THIS ASSIGNMENT AND BILL OF SALE (this "Assignment") dated March 1, 2019, but effective from and after 7:00 a.m., M.D.T. time on November 1, 2018 (said date and time hereinafter referred to as the "Effective Time"), is from **ROSEWOOD RESOURCES, INC.**, a Delaware corporation ("Assignor"), having an office at 2101 Cedar Springs Road, Suite 1500, Dallas, Texas 75201, to **OWN RESOURCES ROCKIES, LLC**, a Delaware limited liability company, whose principal office is located at 38 Palmer Crest, The Woodlands, Texas 77381 ("Assignee"). Capitalized terms not herein defined will have the meaning assigned to such terms in that certain Purchase and Sale Agreement, dated as of December 10, 2018, by and between Assignor and Own Resources, LLC, an affiliate of Assignee (the "Agreement").

WITNESSETH:

FOR AND IN CONSIDERATION of One Hundred and No/100 Dollars (\$100.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, transfer, assign, convey, set over and deliver unto Assignee, its successors and assigns forever, all of Assignor's right, title and interest in and to the following assets (excluding the Excluded Assets as defined below) (such right title and interest, after excluding the Excluded Assets, the "Assigned Property"):

- (a) those oil and gas leases described in Exhibits A and A-1 hereto and all right, title and interest therein or arising therefrom and in the leasehold estates created by such leases and the lands covered thereby or subject thereto, including mineral leasehold, working, overriding royalty, net revenue, net profit, production payment, carried, backin, farmout, farmin and reversionary interests, and all subleases and production payments, but excluding the Excluded Assets (the "Leases");
- (b) the wells (whether producing, shut-in, temporarily abandoned, plugged and abandoned, injection, disposal, water supply or otherwise) identified or described in Exhibit B hereto (the "Wells");
- (c) the overriding royalty, royalty, and revenue interests identified or described in Exhibit C hereto (the "ORRI");
- (d) the surface and subsurface leases, surface fee interests, servitudes, rights-of-way, easements, permits, licenses and other surface rights appurtenant to or used in connection with the Properties, including, but not limited to, the easements and rights of way identified in Exhibit D hereto (collectively, the "ROWS");
