THIS ASSIGNMENT AND BILL OF SALE (this "Assignment") dated March 1, 2019, but effective from and after 7:00 a.m., M.D.T. time on November 1, 2018 (said date and time hereinafter referred to as the "Effective Time"), is from ROSEWOOD RESOURCES, INC., a Delaware corporation ("Assignor"), having an office at 2101 Cedar Springs Road, Suite 1500, Dallas, Texas 75201, to OWN RESOURCES ROCKIES, LLC, a Delaware limited liability company, whose principal office is located at 38 Palmer Crest, The Woodlands, Texas 77381 ("Assignee"). Capitalized terms not herein defined will have the meaning assigned to such terms in that certain Purchase and Sale Agreement, dated as of December 10, 2018, by and between Assignor and Own Resources, LLC, an affiliate of Assignee (the "Agreement").

WITNESSETH:
