**SURRENDER OF OIL AND GAS LEASE
AND
TRANSFER OF LEASE EQUIPMENT**

This agreement, entered into this 31st day of May, 2019, between **Bittercreek Rose Lodge, LLC (Lessor)** and **JayHog Howard LLC (Lessee)** evidences the mutual understanding by both parties to the following:

1. That Lessee, for and in consideration of One Dollar (\$1.00) does hereby agree to surrender and cancel the Oil and Gas Lease dated November 14, 2014 between Robert P. Howard and Marla J. Howard and JayHog Howard, LLC.
2. It is understood by the parties hereto that the original Oil and Gas Lease is currently in effect, with the current Lessor, Bittercreek Rose Lodge, LLC, having purchased the land and mineral rights from the original Lessor, Robert P. and Marla J. Howard.

The legal description of said lease is as follows:



It is further agreed that the Lessee is assigning all interest in the lease equipment currently on the Lease, with the intent being that the Lessor own one hundred percent (100%) of the Lease and Equipment in order to continue operations once this transfer is complete.


Lessee hereby warrants and agrees that the Lease and Equipment is free of all liens and encumbrances, and that Lessee has the right to convey title and ownership in said equipment to the Lessor.
