- (1) Taylor 'A' (also known as Taylor T-19) Well, API No. 15-097-20474, located in the Southwest Quarter (SW/4) of Section Nineteen (19), Township Twenty-seven (27) South, Range Seventeen (17) West, Kiowa County, Kansas;
- (2) Taylor Farms 1-20 Well, API No. 15-097-21646, located in the Northwest Quarter (NW/4) of Section Twenty (20), Township Twenty-seven (27) South, Range Seventeen (17) West, Kiowa County, Kansas,

Including all tangibles, intangibles, equipment, apparatus, machinery, personal property, fixtures, pipelines and other equipment of whatsoever kind, nature and description which are appurtenant to, used or were obtained in connection with the aforementioned wells and used for oil and gas operations thereon (hereinafter collectively referred to as "Assigned Property").

Assignors make no representation or warranty of any kind, nature or description, express or implied, as to the condition of Assigned Property, its merchantability or its fitness for any particular purpose. This Assignment is made without warranty of title; PROVIDED Assignors represent they have created no mortgages, security interests or liens on the Assigned Property and have paid any and all expenses, costs and taxes related to the Assigned Property which could form the basis for a statutory mechanics and/or tax lien.

Assignee has examined the Assigned Property and agrees to accept said property in its present condition, as is, with faults and defects that may be present, if any. Assignee hereby assumes and shall be responsible for and comply with all duties and obligations, express or implied, arising at any time with respect to the Assigned Property, including, without limitation those arising under or by virtue of any lease, law, statute, rule, regulation or order of any governmental authority or court (specifically including, without limitation, any governmental request or other requirement to plug, re-plug, or abandon or re-abandon the Taylor 'A' and/or Taylor Farms 1-20 wells, or take any clean-up, remedial or other action with respect to the Taylor 'A' and/or Taylor Farms 1-20 wells.

This Assignment and rights, privileges, duties and obligations created herein or arising hereunder shall be subject to, interpreted under, governed by and construed in accordance with the internal laws of the State of Kansas.


Assignee and Assignors agree to all the terms and provisions contained in this Assignment and joins in the execution of the same to evidence such agreement.

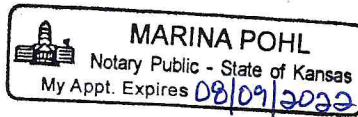

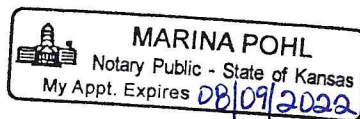
