**ASSIGNMENT OF OIL AND GAS LEASES

- (B) Assignor's undivided interest in and to all producing, nonproducing, and shut-in oil and gas wells, salt water disposal wells, water wells, injection wells, and all other wells on or attributable to the Leases; and
