ASSIGNMENT AND BILL OF SALE

KNOW ALL MEN BY THESE PRESENTS:

TriPower Resources, LLC of P O Box 849, Ardmore, OK 73402 hereinafter referred to as "Assignor", for and in consideration of TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and for the mutual covenants herein contained, does hereby grant, bargain, sell, transfer, assign, convey and deliver unto its heirs, successors and assigns to Crawford Production Company, LLC of P. O. Box 727, El Dorado, KS 67042 hereinafter referred to as "Assignee", ALL of Assignor's right, title and interest, in and to the oil and gas leases and leasehold estate and any working interests in and to the wells and leases described on Exhibit "A", attached hereto and made a part hereof.

Assignor also does hereby grant, bargain, sell, transfer, assign, convey and deliver unto Assignee, its heirs, successors and assigns an equal amount of the right, title and interest, in and to the production, revenue, material, personal property and equipment used for and in conjunction with the wells, oil and gas leases and leasehold estate as described in Exhibit "A".

Notwithstanding anything contained herein to the contrary, it is Assignor's intent to convey all of their right, title and interest in and to any oil and gas interests owned by Assignor, in, under and on the wells, leases and lands set out on the attached Exhibit "A" as of the Effective Date, regardless of whether described correctly in Exhibit "A".

This Assignment of Interests is made subject to the following:

1. The terms, express and implied, covenants and conditions of the Oil and Gas Leases described in Exhibit "A", attached hereto, and all instruments of record by which or through which ASSIGNOR acquired said Oil and Gas Leases, which terms ASSIGNEE hereby assume and agree to perform with respect to the oil and gas mineral rights in and under said land to the extent of their interests in said Oil and Gas Leases.
2. ASSIGNEE bearing their proportionate share of all royalty payments, overriding royalty payments and other payments out of production.

The well(s), leasehold, production and equipment ("Assets") are granted, bargained, sold, transferred, assigned, conveyed and delivered as aforesaid unto Assignee, Assignee's heirs, successors and assigns, subject to the terms and conditions set forth above. Provided further, this Assignment and Bill of Sale is made with full substitution and subrogation of Assignee in and to all covenants and warranties by others heretofore given or made in respect to the property or any part thereof, insofar as such covenants and warranties extend beyond the Effective Date.

Assignor represents that the Assets are free and clear of all liens, encumbrances and adverse claims created by, through and under Assignor. Assignor also represents that to the best of Assignor's knowledge, information, and belief, the Assets have been operated in material compliance with all applicable federal, state and local laws, rules, regulations and orders, including all environmental laws.

It is Assignor's intent to convey to Assignee all right, title, and interest, legal, beneficial, or equitable in the properties described in Exhibit "A" and any and all leasehold in and to the lands and leases described. Assignor agrees to execute and deliver to Assignee all instruments, conveyances, and other documents and to do such other acts not inconsistent with this Agreement as may be necessary or advisable to carry out Assignor's intent. Assignor does hereby agree that after Closing Assignor will continue to execute any and all curative documents and/or instruments of conveyance necessary to transfer title into Assignee covering any rights to the Properties or rights situated adjacent to or in the immediate vicinity of the properties described on Exhibit "A" which may have been inadvertently omitted from Exhibit "A" or may be incorrectly described on Exhibit "A".

Assumptions by Assignee. Without limiting Assignee's rights to indemnity under this Assignment and after Closing, as of the Effective Date Assignee assumes and agrees to fulfill, perform, pay and discharge (or cause to be fulfilled, performed, paid or discharged) all obligations and Liabilities, known or unknown, with respect to the Assets.
