Market, Wichita, KS 67202 ("Assignee"), all of Assignors' right, title and interest in and to the following properties and interests (the "Assets"), less and except the Excluded Assets, as defined below,:

- (A) the oil and gas leases, oil, gas and/or mineral leases, subleases and interests described on Exhibit A, attached hereto, insofar as they cover the lands described on Exhibit A ("Lands"), including any amendments or extensions thereof, and the leasehold estates created thereby, together with all appurtenances, tenements and hereditaments belonging or attaching to the foregoing and all other rights incident to or derived from the foregoing, including all rights, benefits and powers conferred upon Assignors with respect to the use and occupation of the Lands (the "Leases");
- (B) the wells described on Exhibit B, and all tangible personal property, equipment, facilities, fixtures and improvements, including all well heads, casing, tubing, pumps, motors, gauges, valves, heaters, treaters, water lines, vessels, gathering systems, tanks, boilers, separators, treating equipment, compressors, other equipment, and other appurtenances owned or used in connection with the production, treating, storing, transportation or marketing of Hydrocarbons from the wells (collectively, the "Wells");
- (C) all rights and interests in, under or derived from all unitization or pooling agreements in effect with respect to any of the Leases or Wells and the units created thereby (the "Units" and together with Leases and Wells, the "Oil and Gas Properties");
- (D) all contracts and contractual rights to which and to the extent the Oil and Gas Properties are subject, including any operating agreements and pooling and unitization agreements or declarations, in each case, as set forth on Exhibit C attached hereto (the "Contracts");

- (9) the wellbore of the Hutchins #1 Well located in the NENE Section 16-19S-33W, Scott County, Kansas and all rights necessary under the oil and gas leases to access, operate and produce said well for the production of oil and gas, including all equipment and appurtenances thereto.

TO HAVE AND TO HOLD the Assets unto Assignee, its successors and assigns, forever.
