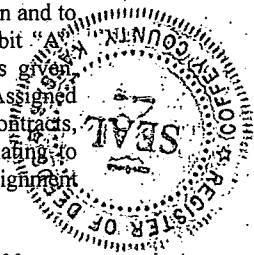

- 3) THIS ASSIGNMENT IS MADE WITHOUT WARRANTY OF TITLE, EITHER EXPRESS OR IMPLIED, AND IS SUBJECT TO ALL VAILIDLY EXISTING ENCUMBRANCES, AGREEMENTS, CONTRACTS (INCLUDING OIL, GAS OR CASINGHEAD GAS SALES AGREEMENTS) WHICH MAY AFFECT SAID ASSIGNED PREMISES.
