The undersigned, **Trans Pacific Energy Partners III LP**, hereinafter called "Assignor", whether one or more, for good and valuable consideration, the receipt of which is hereby acknowledged, do hereby sell, assign, transfer and set over unto **Sebitts Energy Properties LLC**, 100 S. Main, Suite 505, Wichita, Kansas 67202-3738, hereinafter called "Assignee" all of Assignor's working interest in and to the Oil and Gas Leases listed on Exhibit "A", attached hereto and by reference made a part hereof, together with the rights incident therewith.

Assignee agrees to indemnify *Assignor* and hold them harmless from all claims, demands, losses, costs, risk or expenses incident to or resulting from further operations on said lease, for the drilling of additional wells, production of oil and gas, the abandonment and plugging of any well or wells thereon, or the removal of any materials thereon, from and after the effective date of this Assignment. *Assignee* has examined the physical condition of the leases and accepts the leases in an "as-is" condition and further indemnifies *Assignor* from any expenses or claims associated with any environmental issues that may or may not have occurred on the leases.

This Assignment is subject to the terms and conditions of that certain Purchase Agreement Letter, dated April 14, 2020, between Trans Pacific Oil Corporation, Trans Pacific Energy Partners LP and Sebitts Energy Properties LLC. The Ad Valorem Taxes for 2019 will be paid by *Assignor* and the *Assignee* will be responsible for all of the 2020 ad valorem taxes.

Assignor represents that the interests to be sold are free and clear of liens and encumbrances and that the leasehold interests are valid and subsisting and that this assignment is subject to its proportionate share of the existing overriding royalty interest of record as of the effective date of this Assignment.

This Assignment is subject to any Joint Operating Agreement(s) that may exist.

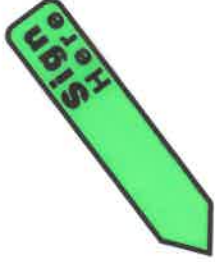
