ASSIGNMENT AND BILL OF SALE

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT is made and entered into this 9TH day of July, 2020, to be effective the 1st day of July, 2020, by and between **William J. Miller Investments, LLC, Brad Miller Companies, LLC, Curtis Hoffman Oil, LLC, and C & K Oil, LLC**, hereinafter collectively referred to as "ASSIGNORS", and **WEBCO Oil Company, Inc.**, 2136 NE 90 Ave., Hoisington, Kansas 67544

, hereinafter called "ASSIGNEE".

WHEREAS, ASSIGNORS own interests (1.0000 W.I.) (.8500 N.R.I.) in a certain oil and gas lease to wit:

Oil and Gas lease dated July 15, 2005, from N.R. Weber and Roy J. Weber, Trustees of the Nick M. Weber and Viola D. Weber Trust No.2, Lessors, to Chris Hoffman d/b/a C & K Oil, Lessee, recorded in Book: Oil and Gas 140, Page 617, Register of Deeds Office, Rice County, Kansas

Insofar and only insofar as said lease covers:

The Northwest Quarter (NW/4) of Section Twenty (20), Township Eighteen (18) South, Range Ten (10) West, Rice County, Kansas

WHEREAS, ASSIGNOR HAS agreed to sell, and ASSIGNEE has agreed to purchase said interests.

NOW, THEREFORE, ASSIGNOR, for and in consideration of the sum of Ten and No/100ths Dollars (\$10.00) to it paid by ASSIGNEE, and other good and valuable considerations, the receipt, adequacy and sufficiency of which are hereby acknowledged, does hereby sell, assign and convey unto ASSIGNEE all of their right, title and interest in and to the above lease together with all of their right, title and interest in and to all wells, permits, easements, licenses, servitudes, well equipment, tank batteries, flow lines, gas fixtures and personal property located on said lease and used in connection with production of oil or gas from said lease together with 3D seismic on the NW/4 20-18S-10W, hereinafter together called "Assets".

THIS AGREEMENT AND BILL OF SALE IS MADE WITHOUT WARRANTIES, EXPRESSED OR IMPLIED IN FACT OR IN LAW, WHETHER OF TITLE, MERCHANTABILITY, FITNESS FOR ANY PARTICULAR PURPOSE, CONDITION OR SAFETY OF THE PROPERTY, COMPLIANCE WITH REGULATORY AND ENVIRONMENTAL REQUIREMENTS OR OTHERWISE.

ASSIGNEE HEREBY AGREES THAT IT HAS INSPECTED THE LEASE AND ASSOCIATED AGREEMENTS, WELLS, PERSONAL PROPERTY AND EQUIPMENT ASSIGNED AND CONVEYED HEREIN AND THAT IT ACCEPTS THE SAME "AS IS" AND "WITH ALL FAULTS".

ASSIGNEE hereby agrees to assume all of ASSIGNORS' responsibility for said wells, the casing and leasehold equipment in and on said wells, and all other personal property used on or in connection therewith on or after the effective date hereof, and ASSIGNEE agrees to protect, defend, indemnify and hold ASSIGNOR and its Directors, Officers, contractors, agents, employees and representatives free and harmless from and against any and all costs, expenses, claims, demands and causes of action of every kind and character arising out of, incident to, or in connection with the lease, land, wells, casing, leasehold equipment, and other personal property hereby conveyed, or ASSIGNEES' or other parties' operations on said leases and said land, arising and occurring on or after the effective date hereof.

ASSIGNEE shall properly plug and abandon all wells herein assigned and shall clean and restore the surface at ASSIGNEE's expense and in accordance with the applicable lease provisions and State and Federal laws, rules and regulations pertaining to the plugging and abandoning of such wells and the restoration of such surface.

THIS AGREEMENT and SALE is to be treated as an occasional sale, and no sales tax is being collected from ASSIGNEE. If, however, this transaction is later deemed to be other than an occasional sale, ASSIGNEE agrees to be solely responsible for any and all sales taxes due on equipment, material and property hereby assigned and sold, and ASSIGNEE shall remit such sales taxes to the property taxing authority. 100% of the ad valorem taxes attributed to the interests assigned for the year 2020 shall be the obligation of the ASSIGNEE.

ASSIGNEE agrees to perform all operations in compliance with all applicable local, state, and Federal Laws, orders, rules and regulations, and to observe, perform and abide by all of the lease terms and provisions, express and implied, applicable to ASSIGNORS' interest in the assigned premises. ASSIGNEE further agrees to secure the bonds, permits and other documents as required by the appropriate regulatory authority which are necessary to effectuate the transfer of interests hereby and/or to cause the release of ASSIGNORS' continued liability as lessee or operator. The parties hereto agree to execute such additional documents or instruments as necessary to transfer ASSIGNORS' interest in any State, Federal or Indian leases assigned hereby to ASSIGNEE.

ASSIGNEE accepts this transfer of lease and interest assigned hereby subject to any and all covenants in instruments in the chain of title and to any outstanding agreements, whether recorded or not, which may include but not be limited to agreements for options, leases, permits, rights-of-way, easements, water disposal systems, licenses, operating agreements and production sales agreements; and in this regard, ASSIGNEE assumes all duties and obligations associated with said outstanding agreements if any.

THIS ASSIGNMENT and BILL OF SALE shall be binding upon and inure to the benefit of the heirs, successors, personal representatives and assigns of the respective parties hereto.

TO HAVE AND TO HOLD the above described property with all and singular rights, privileges and appurtenances thereto or any wise belonging to said Assignor herein, its heirs, successors, personal representatives, administrators, executors and assigns forever.

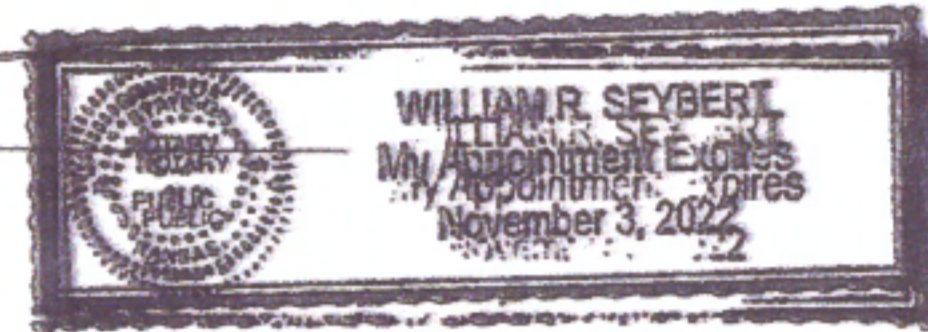
