

Assignees will assume all ad valorem property taxes owed in connection with the interests being transferred.

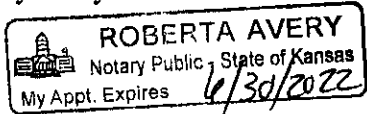


