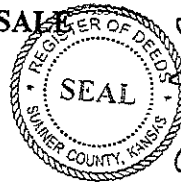

A Water Disposal Agreement dated January 14, 2003, with James M. Brooner et. al. in the Northwest Quarter (N/W) Section 9, Township 31 South, Range 1 West, Sumner County, Kansas, a \$2750.00 dollar payment is due annually on or before January 15, currently payable to Elaine Brooner.

This Assignment is inclusive of all rights, privileges, benefits and powers with respect thereto and the use and occupancy which are necessary or incidental to possession and enjoyment thereof under the terms of the Leases applicable thereto, including but not necessarily limited to the following:

- ◆ Ongoing expenses pertaining to operation of Oil and Gas Leaseholds and/or the disposal well shall be paid in full to the date of Closing;
- ◆ All crude oil may be run down to "draw offs" by the end of business day, November 30, 2020;
- ◆ Property taxes for 2020 shall be paid by the Assignors;

- ◆ This document shall be considered a "**Bill of Sale**" as to the personal property herein sold, and the Assignor/Operator, shall cooperate in the change of Operator License required of the Kansas Corporation Commission;
- ◆ Upon payment of purchase monies, the Assignors shall release this document for recording in the Sumner County Register of Deed's Office;
- ◆ The parties shall share the expenses of all documents to consummate this transaction, including legal fees, which shall be reconciled at Closing.

The Leaseholds herein assigned and the personal property herein sold are being conveyed to, and accepted by, Assignee in its "as is" "where is" condition and state of repair with all faults and defects without any representation, warranty or covenant of any kind, including but not limited to warranties of merchantability, condition or fitness for a particular purpose either expressed or implied. It is understood and agreed that Assignee has had the opportunity to inspect the property and premises and is satisfied as to the physical and environmental condition, both surface and subsurface and that Assignee accepts all of the same in their "as is" "where is" condition. The Assignee further acknowledges that the Assignors makes no warranty or representation expressed or implied as to the accuracy or completeness of any data, information, materials heretofore or hereafter furnished Assignee in connection with the Oil and Gas Leasehold interest or as to the quality or quantity of hydrocarbon reserves, if any, attributable to the interest or the ability of the leaseholds to produce hydrocarbons. Any and all such data, information, and other materials furnished by the Assignor/Operator is provided to Assignee as a convenience and any reliance on or use of the same, shall be at the Assignee's sole risk.

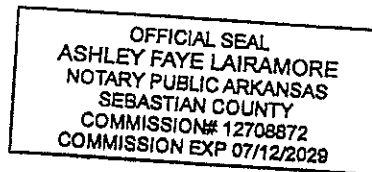


