PURCHASE AND SALE AGREEMENT

THIS PURCHASE AND SALE AGREEMENT ("Agreement") is made and entered into effective the 1st day of April, 2020, by and among Rodney Brown d/b/a M.J.T. Oil Company; Ward D. Craig d/b/a Craig Oil Company; Ward D. Craig and Crystal J. Craig, husband and wife; Todd Alan Templeton a/k/a Alan Templeton; and Kaylee A. Karst, hereinafter collectively referred to as "SELLERS", and Webco Oil Company, Inc., hereinafter referred to as "PURCHASER."

RECITALS

WHEREAS, on the terms and conditions provided in this Agreement, Sellers desire to sell and Purchaser desires to purchase Sellers' interest in certain Oil and Gas Leases Operating Agreements and operating rights in and to properties hereinafter more particularly set forth:

NOW, THEREFORE, for good and valuable consideration and for the mutual covenants contained herein, Sellers and Purchaser agree as follows:

ARTICLE 1. SALE AND PURCHASE

- 1.1 <u>Effective Time</u>: The effective time and date of the purchase and sale contemplated hereby shall be April 1, 2020, at 7:00 AM, at the site of the respective Subject Properties (The "<u>Effective Time</u>").
- 1.2 <u>Sale and Purchase</u>: Subject to the terms and conditions herein contained, at Closing and as of the Effective Time, Sellers shall sell, assign, transfer and convey to Purchaser, and Purchaser shall purchase and receive, the following described assets (the "<u>Assets</u>"):
 - (a) Sellers' working and net revenue interest represented to be 75% working interest (.75000 W.I.) and 62.53125 % net revenue interest (.62531250 N.R.I.) in and to the following Oil and Gas Lease:

Oil and Gas Lease dated April 6, 1993, from Nick M. Weber and Viola D. Weber, Lessors, to Pelican Hill Oil and Gas, Lessee, recorded in Book 531, Page 10, Register of Deeds Office, Barton County, Kansas, insofar as said lease covers the East Half of the Northeast Quarter (E/2 NE/4) of Section Sixteen (16), Township Sixteen (16) South, Range Twelve (12) West, containing 80 acres, more or less, Barton County, Kansas,

Together with the rights incident thereto and personal property thereon, appurtenant thereto, or used or obtained in connection therewith

(b) All of Sellers' right to operate said oil and gas lease

ARTICLE 2. CONSIDERATION

- 2.1 <u>Consideration</u>: As consideration for this Agreement and the transfer of the assets at Closing, Purchaser shall pay to Sellers the total sum of Thirty Thousand and no/100 Dollars (\$30,000.00), (the purchase price).
 - 2.2 Manner of Payment: At Closing, Purchaser shall pay the purchase price by certified funds or wire transfer of immediately available funds and according to Sellers' written instructions delivered to Purchaser before Closing. Sellers agree that purchase price will be made to Craig Ward d/b/a Craig Oil Company, who shall disburse to remaining sellers their share of the purchase price.

ARTICLE 3. TITLE

- 3.1 <u>Definition of Acceptable Title</u>: As used herein, the term acceptable title shall mean as to the assets, such right, title and interest that: a) entitles the purchaser as sellers' successor-in-title to receive not less than the net revenue interest set forth of all oil, gas and associated liquid, gaseous hydrocarbons produced, saved and marketed from the Lease interest; b) obligates Purchaser as Sellers' successor-in-title to bear costs and expenses related to the maintenance, development and operation of all wells located on the respective Lease, in an amount not greater than the working interest set forth; and: c) said interests are free and clear of all liens, mortgages and claims.
- 3.2 <u>Notification of Defects</u>: Purchaser shall notify Sellers within 5 days prior to closing of any defects in Sellers' title. Sellers shall have the option to cure any such defect or terminate this agreement.

ARTICLE 4. OPERATING RIGHTS

4.1 <u>Operating rights</u>: Sellers agree to transfer, pursuant to administrative regulatory requirements, operating rights as to the Oil and Gas Lease. Sellers will prepare the appropriate T-1 and all other forms necessary to effect transfer of operations as of effective date and deliver the same to Purchaser at closing.

ARTICLE 5. ASSIGNMENTS

5.1 <u>Assignments</u>: Seller shall prepare assignments and conveyances of Sellers' interest in and to the assets and submit said assignments to Purchaser prior to closing in such form as is acceptable to Sellers and Purchaser.

ARTICLE 6. TAXES

The interest of the Sellers shall be subject to Sellers' payment of all expenses related to Sellers' interest in and to the Oil and Gas Lease incurred through March 31, 2020.

ARTICLE 7. <u>LEASE AND LAND FILES AVAILABLE</u> FOR INSPECTION PRIOR TO CLOSING

7.1 <u>Lease and Land Files Available for Inspection Prior to Closing</u>: Sellers' file incident to leasehold ownership and operations incident to the Leases being purchased shall transfer to Purchaser at closing. Said files shall be delivered to purchaser at closing.

ARTICLE 8. OPERATIONS

8.1 Operations: Sellers shall continue operating the operated leases to date of closing in compliance with applicable laws, ordinances, rules, regulations and orders and in prudent, good and workmanlike manner, maintain insurance now in force with respect to the properties and pay or cause to be paid all costs and expenses in connection therewith. In the event of any unforeseen mechanical event occurring on a lease, Purchaser shall be notified by Sellers of such event, and Sellers and Purchaser will mutually determine how to proceed.
