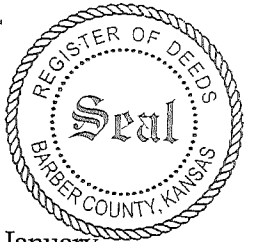

**ASSIGNMENT AND BILL OF SALE**

THIS ASSIGNMENT AND BILL OF SALE is dated effective as of the 1<sup>st</sup> day of January, 2021 (the "Effective Date"), by and between **Woolsey Energy Corporation**, 125 N. Market St., Ste. 1000, Wichita, KS 67202, hereinafter referred to as "Assignor", and **Lynn Packard**, 8113 NW River Rd., Medicine Lodge, KS 67104, hereinafter referred to as "Assignee",

WITNESSETH

Assignor, for and in consideration of the sum of Ten Dollars (\$10.00), and other good and valuable consideration, in hand paid, the receipt and sufficiency of which is hereby acknowledged, does hereby grant, bargain, sell, assign, transfer and set over unto Assignee, its successors and assigns:

1. All of Assignor's right, title and interest in, to and under the oil and gas lease and the leasehold estate created thereby, which is set forth and described in Exhibit "A", which is attached hereto and made a part hereof by this reference, hereinafter called the "Subject Property";
2. 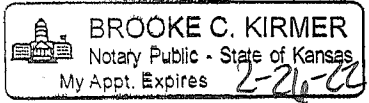
