ASSIGNMENT, CONVEYANCE AND BILL OF SALE

KNOW ALL MEN BY THESE PRESENTS: That,

Hummon Corporation, a Kansas corporation (hereinafter referred to as "Assignor"), for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby grant, bargain, sell, convey and assign unto SNR Kansas Operating, LLC, an Oklahoma limited liability company (hereinafter referred to as "Assignee"), all of Assignor's right, title and interest in and to the following:

- A. All of Assignor's right, title and interest in and to the oil, gas and other mineral leases, rights and properties described or referred to in Exhibit A attached hereto, being hereinafter referred to as the "Subject Leases". The lands described in said leases and the personal property located thereon are hereinafter referred to as the "Subject Land";
- B. All of the presently existing oil and gas sales, purchase, exchange and processing contracts, casinghead gas contracts, and all other contracts, agreements and instruments that relate to the Subject Leases and the production and sale of oil, gas and other minerals from or attributable to the Subject Land;
- C. All personal property, improvements, leases and well equipment, easements, permits, licenses, servitudes and rights-of-way including, without limitation, all wells, casing, tubing, tanks, separators, buildings, fixtures, machinery, injection facilities, salt water disposal facilities, compression facilities, and other equipment, processing plants, gathering systems, pipelines, power lines, telephone and telegraph lines, roads and other appurtenances and easements situated upon or used or held for future use in connection with the exploration, development and operation or maintenance of the Subject Leases, or in connection with the production, treating, storing, transportation or marketing of oil, gas and other minerals produced from or allocated to the Subject Leases; and

- 2. The interests hereby assigned in the Subject Leases shall bear their proportionate share of all royalties, overriding royalties, production payments, and other burdens on production to which the Subject Leases are subject on the Effective Date hereof.
- 3.
