Main, Eureka, KS 67045 ("Seller") for and in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00) and other good and valuable consideration paid by **NORTHERN NATURAL GAS COMPANY**, a Delaware corporation, with principal operational offices at 1111 South 103<sup>rd</sup> Street, Omaha, Nebraska 68124-1000, ("Buyer"), does hereby grant, sell, transfer, convey and deliver to Buyer all right, title, and interest, subject to an unrecorded Release, Sale & Settlement Agreement dated December 31<sup>st</sup>, 2020, to the well bores and well pads for those certain wells described on **Exhibit "A"** hereto (collectively the "Assets").

The intent of this Bill of Sale is for Seller to convey to Buyer all right, title, and interest in the well bore(s), well head and well pads for each of the well(s) identified above and the intent of Seller to retain and remove any and all other equipment located at each of the well(s) identified above. Buyer acquires no obligations held by Seller under any oil and gas lease. Any remaining obligations under any oil and gas lease held by Seller remain the obligations of Seller. Buyer is in no way obligated to perform under Seller's oil and gas leases. Seller expressly states that Seller will continue to perform any remaining obligations under Seller's oil and gas leases.

Seller for itself, its successors and assigns, covenants with Buyer, its successors and assigns, that the Assets are free from all encumbrances made by Seller, and that Seller, its successors and assigns shall WARRANT AND DEFEND same unto Buyer, its successors and assigns, against every person whomsoever lawfully claiming by, through or under Seller, or any present affiliate of Seller, but against none other but with full right of substitution and subrogation against all former owners of the Assets.

The Assets are sold to Buyer in their "as is", "where is" condition, and Seller makes no warranty or representation of any kind, oral or written, express or implied, regarding its fitness for a particular purpose.



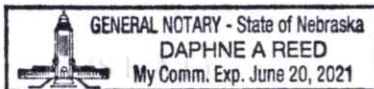



Northern Natural Gas Company (Northern) has purchased two wells from Daystar Petroleum, Inc. (Daystar) in Section 11-T20S-R8W, Rice County, Kansas, the Edwards B1 well located in the SW ¼ NW ¼ SE ¼ and the Sangster 1 well located in the SE ¼ NE ¼ SW ¼. Northern will convert the wells to underground gas storage pressure observation wells if the wells are found to be in mechanically useable condition. If either or both of the wells are not found to be in mechanically useable condition they will be permanently plugged and abandoned.
