ASSIGNMENT OF OIL AND GAS LEASE

KNOW ALL MEN BY THESE PRESENTS

That the undersigned, MID-CONTINENT ENERGY CORPORATION, hereinafter referred to as "Assignor", for good and valuable consideration, the receipt of which is hereby acknowledged does hereby transfer, sell, convey, and set over unto THOMAS GARNER, INC., herein after referred to as "Assignor", a gross 19.8182% working interest in and to the following Oil and Gas Lease, to-wit:

Oil and Gas Lease dated January 24, 1997, by and between John R. Booth and Ruby I. Booth, as Lessors, to J. Fred Hambright, Lessee, covering the Southwest Quarter (SW¼) Section 20; East Half of the Northwest Quarter (E½ NW¼) and the Northeast Quarter (NE¼) Section 29, all in Township 30 South, Range 17 West, Kiowa County, Kansas, containing 400 acres more or less, recorded in Book 20, Page 900.

INSOFAR AS AND ONLY INSOFAR AS said leases cover the Southwest Quarter (SW¼) Section 20; the East Half of the Northwest Quarter (E½ NW¼); West Half of the Northeast Quarter (W½ NE¼) and the North Half of the Northeast Quarter of the Northeast Quarter (N½ NE¼ NE¼) Section 29, Township 30 South, Range 17 West, Kiowa County, Kansas, containing 340 acres, more or less, recorded in Book 20, Page 900.

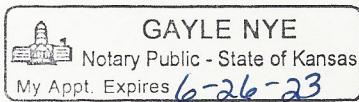
