NASH OIL & GAS, INC., a Kansas corporation, with its principal offices at 624 Autumn Ridge Road, Newton, Kansas 67114 ("Seller") for and in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00) and other good and valuable consideration paid by NORTHERN NATURAL GAS COMPANY, a Delaware corporation, with its principal offices at 1111 South 103<sup>rd</sup> Street, Omaha, Nebraska 68125-1000 ("Buyer"), does hereby grant, sell, transfer, convey, and deliver to Buyer all right, title, and interest, subject to an unrecorded Release, Sale & Settlement Agreement (the "Agreement") dated February 3, 2021, to the well bore and well pad (collectively the "Assets") for that certain well, commonly referred to as the Holland 1-26 located in the County of Pratt, State of Kansas at:

Buyer acquires no obligations held by Seller under any oil and gas lease. Any remaining obligations under any oil and gas lease held by Seller remain the obligations of Seller. Buyer is in no way obligated to perform under Seller's oil and gas lease for the above identified property. Seller expressly represents and affirms that it will continue to perform all remaining obligations under Seller's oil and gas lease for the above identified property, if any.

Seller for itself, its successors and assigns, covenants with Buyer, its successors and assigns, that the Assets are free from all encumbrances made by Seller, and that Seller, its successors and assigns, shall warrant and defend same unto Buyer, its successors and assigns, against every person whomsoever lawfully claiming, by, through, or under Seller, or any present

affiliate of Seller, but against none other but with full right of substitution and subrogation against all former owners of the Assets.


