**ASSIGNMENT OF OIL AND GAS LEASES AND SALTWATER DISPOSAL AGREEMENTS**

O. Box 183, Sterling, KS 67579** ("Assignee"), all of Assignor's (1) working interest in the Leases, subject to the following reservation, and (2) interest in the Agreements, together with the rights incident thereto and the personal property thereon, appurtenant thereto, or used or obtained in connection therewith, and subject to all existing royalty and overriding royalty interests as the same appear of record.

Assignors reserve to RMR Enterprises, LLC an overriding royalty interest in each of the Leases equal to the difference between 18.75% and the existing royalty and overriding royalty burdens applicable to said Leases. It being the intent of Assignors that the net revenue interest in each of the Leases assigned to Assignee equals 81.25%.

This Assignment is subject to the terms and conditions of that certain Purchase and Sale Agreement, dated May 27th, 2021, between Assignors and Assignee, the terms and conditions of which are made a part hereof and incorporated herein by reference.

Assignors make this Assignment with the following, exclusive warranty: Assignors warrant that the Leases and Agreements are transferred and conveyed to Assignee free and clear of all liens and encumbrances created by or arising through Assignors only. Other than the immediately preceding special warranty of title, Assignors make this Assignment without any representations or warranties of any kind, either express, implied or statutory, including any implied warranty of merchantability or fitness for a particular purpose.
