At this time, TYLUKA Operations, LLC is offering Hoffman Resources, LLC the sum of [REDACTED] to purchase 100% of the working interest in the Allphin and Allphin-Towns leases. Said leases are located in the SW/4 of Sec. 33, T9s-R21w in Graham County. This purchase includes all oil and gas wellbores, injection and disposal wells, and any and all personal property and equipment associated with and used in production of oil and gas, and free of liens and encumbrances. TYLUKA Operations, LLC will be responsible for all plugging liabilities associated with this purchase.

If accepted, change of operatorship will be effective July 1, 2021. Final gauges will be taken July 1, 2021 at 7:00 a.m., and any produced oil in the tanks above pipeline will be prorated back to Hoffman Resources LLC. All expenses incurred prior to July 1, 2021 will be the responsibility of Hoffman Resources LLC and all expenses after July 1, 2021 will become the responsibility of TYLUKA Operations, LLC.

The Purchase and sale of this agreement will be final once the assignment of interests has been mutually agreed on and executed by both parties.
