Volunteer Unit Lease wells #62 & #63 were drilled in 2012 by Bauer Oil Investment, LLC. All documentation submitted to the Commission regarding these wells listed their location as being in Section 35, T29S R15E, Wilson County. Subsequent investigation by Verde Oil Company found that these wells are actually located in Section 27, T29S R15E, Wilson County. Information has been provided to the Commission documenting the actual location of these wells and their location has been corrected in the database. Because Section 35 is not within the leasehold of the Volunteer Unit Lease a number of Change of Operator (T-1's) have been filed that do not include these wells.
