## ASSIGNMENT AND BILL OF SALE

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT is made and entered into this 31st day of August, 2021, to be effective the 1<sup>st</sup> day of September, 2021, by and between Petroleum Technologies, Inc., hereinafter called Assignor, and RJM Oil Company, Inc., hereinafter called Assignee.

WHEREAS, Assignor owns the following-described oil and gas well together with all equipment and other personal property used in connection with the production of oil and gas therefrom, all of which is located in Rice County, Kansas, and described as follows:

Well Name: Weatherbee #1

Location: 990' North and 480' West from the Southeast Quarter (SE/4) of Section Twenty-seven (27), Township Eighteen (18) South, Range Ten (10) West

Hereinafter "Weatherbee #1".

WHEREAS, Assignor has agreed to sell and Assignee has agreed to purchase the wellbore of the Weatherbee #1, along with the "Assets" as described below.

NOW, THEREFORE, Assignor, for good and valuable consideration, the receipt of which is hereby acknowledged, does hereby sell, assign, and convey unto Assignee all right, title, and interest in and to the wellbore of the Weatherbee #1, including but not limited to the "Assets" defined as all wells, permits, easements, licenses and servitudes, well equipment, tank batteries, flow lines, gas fixtures, and all other equipment and personal property used or useable in connection with production of oil or gas from the Weatherbee #1.

ASSIGNOR AND ASSIGNEE hereby agree that all sellable oil currently in stock tanks associated with the Weatherbee #1 shall be the property of Assignee. Assignee further agrees that it will be responsible for ad valorem taxes for the calendar year of 2021 and all years thereafter.

ASSIGNOR warrants that it has marketable title to all the property assigned herein; that all the property is free of liens, encumbrances, or claims by third parties. Assignor further indemnifies and holds harmless the Assignee from any and all claims, causes of action, and damages related to third party claims of ownership in and to the Weatherbee #1 and the Assets.


ASSIGNEE hereby agrees that it has inspected the Weatherbee #1 and Assets assigned and conveyed herein and accept the same as-is and with all faults. Assignee further agrees to indemnify and hold harmless the Assignor from all claims, demands, losses, costs, risks, and expenses incident to or resulting from operations, drilling of additional wells, production of oil or gas, the abandonment and plugging of any well or wells thereon or the removal of any materials therefrom from and after the effective date of this Assignment.

ASSIGNEE shall be responsible for plugging and abandoning the well herein assigned and shall clean and restore the surface at Assignee's expense and in accordance with applicable State and Federal

laws, rules, and regulations pertaining to the plugging and abandoning of said well and the restoration of such purpose.


