- b) All contracts and contractual and legal rights of every nature, or the production or proceeds therefrom, including, without limitation, all operating agreements, gas purchase contracts, division orders, permits, salt water disposal agreements, easements, rights of way, surface leases, and other contracts and servitudes, together with the right to enforce, collect, and receive any amounts or indebtedness owing under any agreements; and

Assignee hereby assumes any and all obligations and liabilities of any kind of Assignor, whether known or unknown, in any way related to the interests assigned hereunder, specifically including the obligation to plug and abandon the wells located on lands covered by the Leases, and to pay all royalties, overriding royalties, rents, shut-ins, and other payments due under the Leases.

This Assignment may be executed in any number of counterparts, each of which shall be deemed an original instrument, but all of which, together, shall constitute but one and the same instrument.

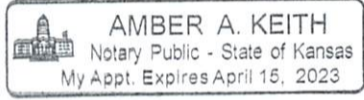

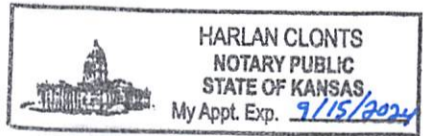
