THIS ASSIGNMENT AND BILL OF SALE (this "Assignment") dated effective as of April 1, 2022, at 12:00 a.m. (the "Effective Time") is from the undersigned parties hereto (collectively, the "Assignor," whether one or more) to **M & M Well Service, LLC**, a Kansas limited liability company, whose address is 15326 NW River Road, Lake City, KS 67071 (the "Assignee").

### ASSIGNMENT

**Assignment.** NOW THEREFORE, Assignor, for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, in hand paid, the receipt and sufficiency of which is hereby acknowledged, does hereby GRANT, BARGAIN, SELL, ASSIGN AND CONVEY, and have by these presents GRANTED, BARGAINED, SOLD ASSIGNED AND CONVEYED unto Assignee, all of Assignor's right, title and interest in and to the following assets (collectively the "Subject Interests"):

- c. all of Assignor's right, title and interest in the personal property, fixtures, equipment, flowlines, gathering lines, pipelines and facilities located on the Lands that are used in connection with the operation or production of the Wells as of the Effective Time, but excluding any automobiles and automotive equipment (the "Equipment");
- d. all of Assignor's right, title and interest in oil, casinghead gas, condensable, gaseous and liquid hydrocarbons and all components of any of them produced from the Leases, Lands or Wells (the "Hydrocarbons") and attributable to periods of time from and after the Effective Time;

This assignment is made without covenants of warranty of title, either express or implied, all of which are hereby disclaimed, but is made with full substitution and subrogation of Assignee in and to all covenants and warranties by others heretofore given or made in respect of the interests assigned hereunder. The Subject Interests are assigned and transferred to Assignee **“AS IS”, “WHERE IS” AND WITH ALL FAULTS. ASSIGNOR MAKES NO WARRANTY OF ANY KIND OR NATURE WITH RESPECT THERETO, AND ASSIGNOR EXPRESSLY DISCLAIMS AND NEGATES ANY IMPLIED, EXPRESS OR STATUTORY WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE.**

Assignor and Assignee covenant and agree to execute and deliver, or shall cause to be executed and delivered, from time to time such further instruments of conveyance and transfer, and shall take such other actions as Assignor or Assignee may reasonably request, to convey and deliver the Subject Interests to Assignee. Without limiting the generality of the foregoing, Assignee shall accept responsibility for operations of the Wells by appropriate filings made with the Kansas Corporation Commission.



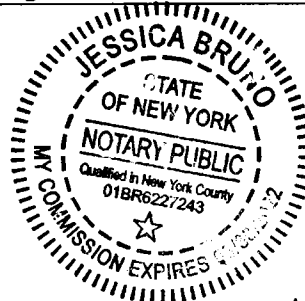
