The working interests and net revenue interests in the Leases and Wells stated on Schedule 1 are for purposes of this warranty of title, but do not constitute a limitation on the interests assigned hereunder, which shall include all of Assignor's working interest in and to the Leases.

This Assignment of Working Interest in Oil and Gas Leases is made subject to the terms, conditions, representations, warranties and covenants set forth in that certain Letter Agreement entered into April 9, 2022, by and between Assignor and Assignee.

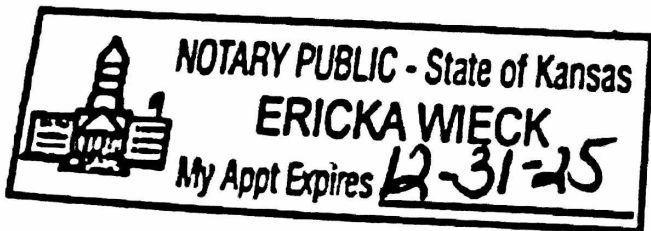

That certain Letter Agreement dated May 8, 2020, by and between Oil Productions, Inc. of Kansas ("OPIK"), and C. W. Boles on behalf of CWB Oil Company, LLC ("CWB"), pertaining to the right of CWB to dispose of saltwater produced from the Albin #1 on the Albin Lease (described above) into the Braun #1 injection well operated by OPIK located in the SW/4 of Section 26-T13S-R17W, Ellis County, Kansas.
