**Purchase and Sales Agreement**

Gentlemen:**

This letter is to put into writing our agreement whereby **Patterson Energy LLC**, (Purchaser) agrees to purchase from **Trans Pacific Oil Corporation**, et al (Seller), the wellbore, referred to as the **Marcotte #1-33** located 990' FNL & 330' FEL of Sec. 33-T9S-R20W Rooks County, Kansas per the following terms and conditions. If the terms and conditions properly state the Agreement between Purchaser and Seller, please so indicate by executing this Letter Agreement in the space provided on the last page of said Agreement, and Seller should return the original to **Trans Pacific Oil Corporation**.

1. Purchaser agrees to pay Seller \$5000 ("purchase price") for the wellbore.
2. The effective date will be the date of close ("effective date").
3. Seller agrees to remove all production equipment from the Marcotte lease no later than June 1<sup>st</sup>. It is understood that only the Marcotte #1-33 cased well bore will remain.
4. Any ad valorem property taxes for 2021 shall be paid by the Seller. All 2022 and future ad valorem taxes will be paid by Purchaser.
5. On, after and as of the effective date, Purchaser shall assume full responsibility for the property purchased and shall protect, defend, indemnify, and hold Seller, its officers, employees, or agents, harmless from and against any and all losses, claims, demands, suits, causes of action and sanctions of every kind including reasonable attorney's fees and court costs, arising from the operation of, or in any way pertaining to the lease described above after the effective date. This shall include all plugging, restoration and clean-up of the lease and production facilities.
6. SELLER MAKES NO REPRESENTATIONS OR WARRANTIES AS TO THE ACCURACY OR COMPLETENESS OF THE INFORMATION FURNISHED. THE PROPERTY AND THE EQUIPMENT AND MATERIAL WILL BE SOLD ON AN "AS IS" AND "WHERE IS" BASIS AND IS NOT GUARANTEED AS TO QUANTITY, SIZE, WEIGHT, OR SERVICEABILITY.
7. Upon closing, Purchaser shall tender to Seller, the entire purchase price.
8. Upon closing and payment in full, Seller and Purchaser shall acknowledge, execute and submit T-1 forms, along with any other regulatory documents, as required by the Kansas Corporation Commission citing Purchaser as Operator from the closing date.

9. Upon closing and payment in full, Seller will deliver to Purchaser a fully executed Assignment and Bill of Sale.
10. Unless otherwise provided herein, these terms and conditions will be binding on, and inure to the benefit of Purchaser and Seller and their respective heirs, representatives, successors, and assigns.
11. Closing shall occur on or before June 1, 2022.
