MEMORANDUM OF SALE AND PURCHASE AGREEMENT

Box 250, Ottawa, KS 66067 and **ROGER KEITH**, an individual, (collectively "Seller"), did by unrecorded written instrument, agree to sell the following described oil and gas leases and all personal property and equipment located thereon to **BWC ENERGY LLC**, a Kansas limited liability company, 37365 W. 175th Street, Edgerton, KS 66021 ("Buyer"):

The purchase price and the terms of the sale have been agreed upon and reduced to writing by the above named parties. During executory period of the aforesaid Purchase and Sale Agreement, the above named Parties have agreed that Seller may not release the above referenced leases, pledge or encumber said leases, or otherwise convey said oil and gas leases or the personal property located thereon to any other party.

During the term of the aforesaid Purchase and Sale Agreement, Buyer, shall have the right to operate said oil and gas leases or designate the operator of said oil and gas leases and perform any and all acts that could be performed by the Lessee of said oil and gas lease, and all moneys payable to the working interest owned by Seller shall be paid one-half to Reusch Well Service, Inc., and one-half to Buyer by any crude oil purchaser during the term of the Purchase and Sale Agreement. Notwithstanding anything to the contrary in the foregoing Buyers, shall not sell any pump jacks or injection equipment on the leases without Seller's written consent during the executory period of the Purchase Sale Agreement and Buyer shall cause all Leases to continue to produce in paying quantities at all times during such time.



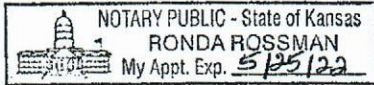

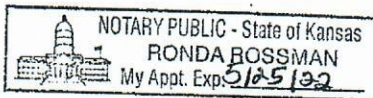
